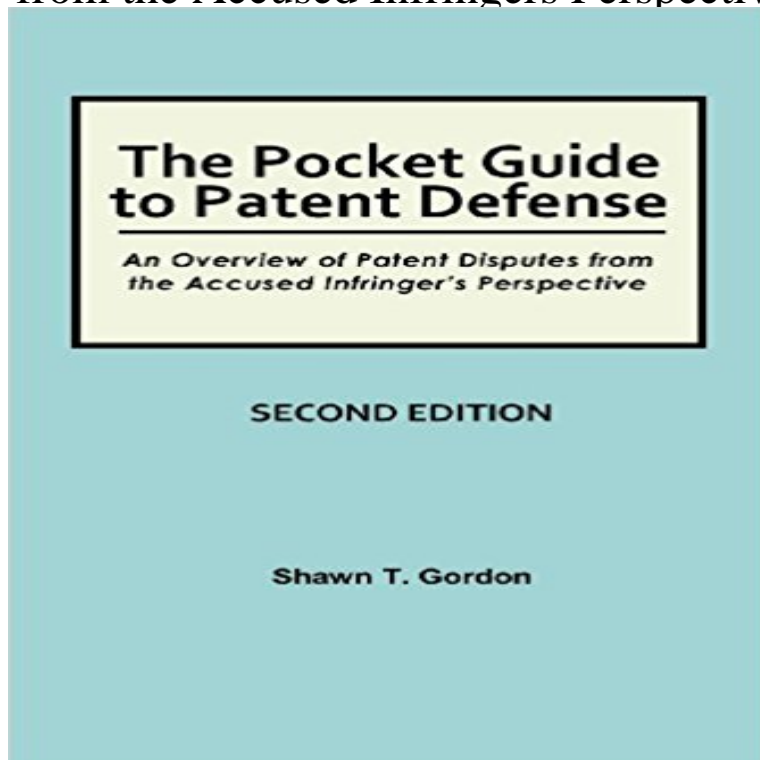


The Pocket Guide to Patent Defense: An Overview of Patent Disputes from the Accused Infringers Perspective Second Edition
