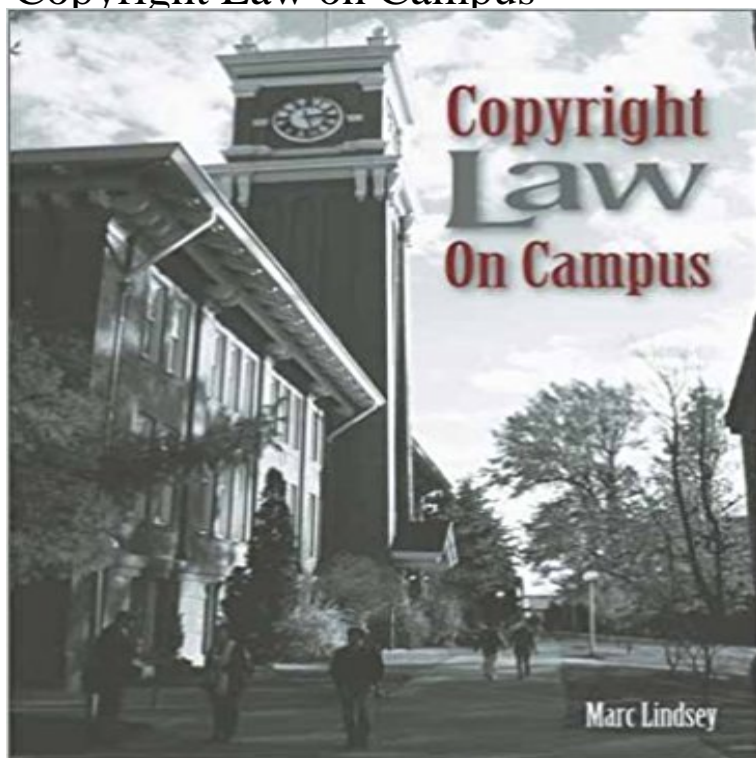


## Copyright Law on Campus
