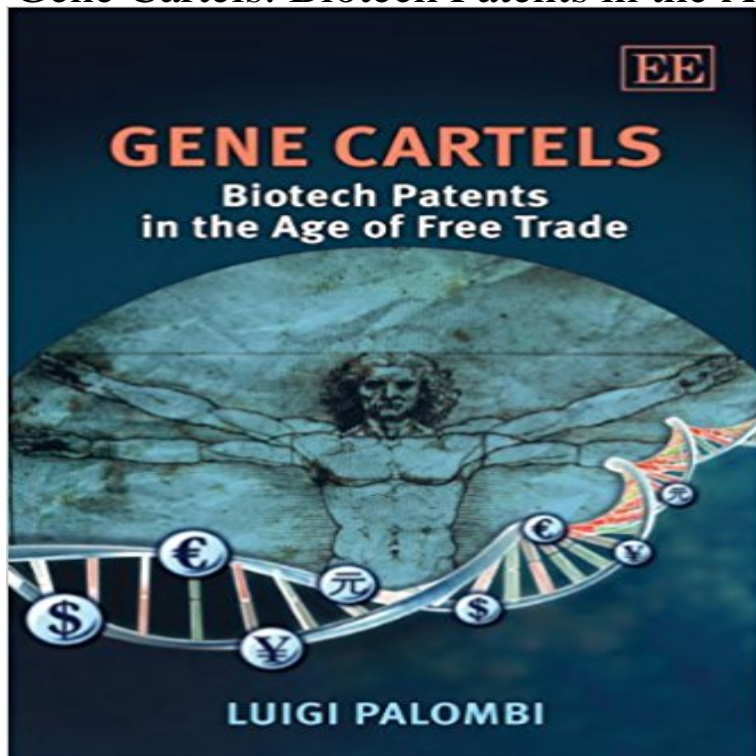


## Gene Cartels: Biotech Patents in the Age of Free Trade

This book questions whether the continuing grant of patents can be justified when they are now used to suppress, rather than promote, research and development in the life sciences.
