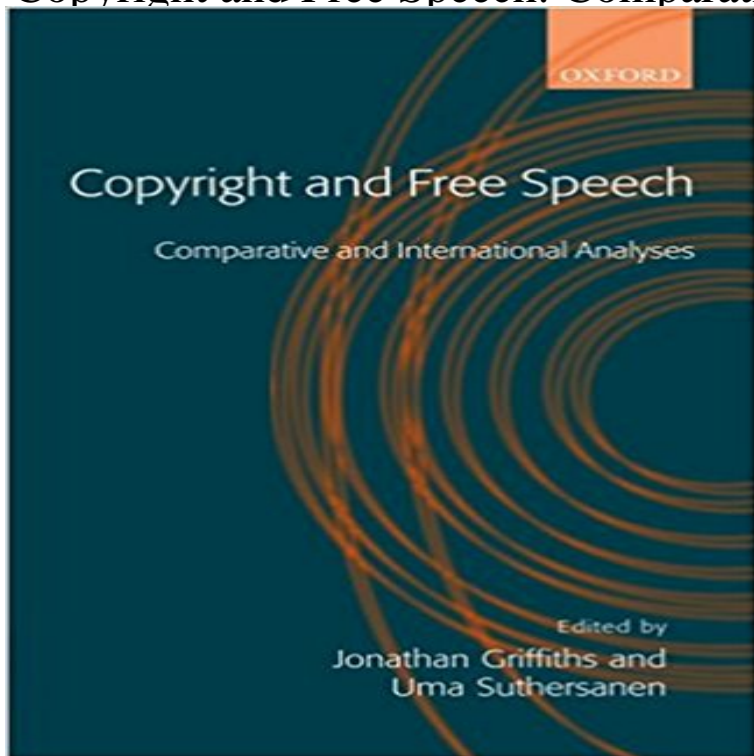


# Copyright and Free Speech: Comparative and International Analyses
