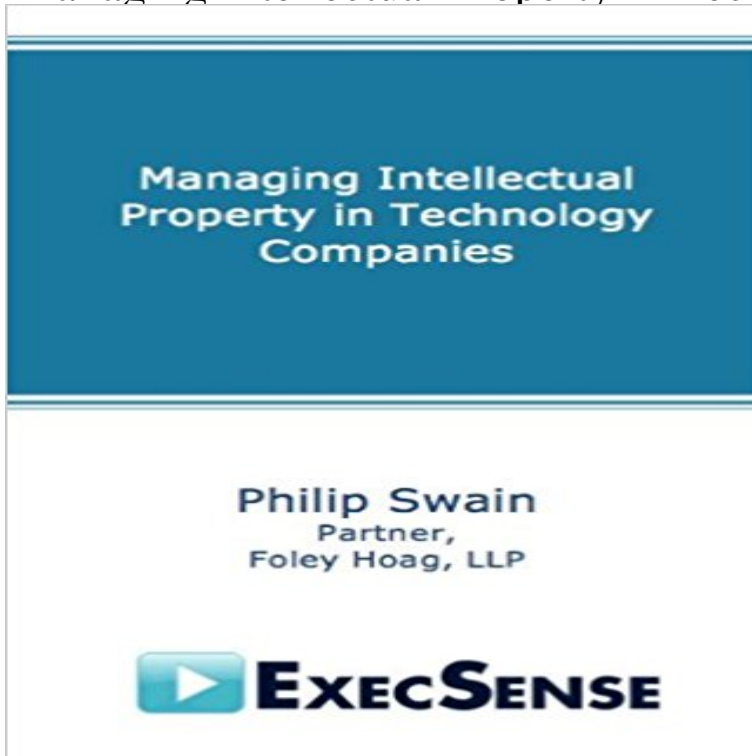


Managing Intellectual Property in Technology Companies



Technology companies now must have an intellectual property strategy in place in order to be competitive. This includes both an offensive strategy intellectual property to protect the companys core technology from being copied by competitors, and to enable the company to monetize its innovations through licensing or sale; and a defensive strategy, to prevent the company from being attacked by competitors, or if it is attacked, to allow it to fight back with counterclaims of its own, or to resolve the dispute through cross licensing. Developing an intellectual property strategy in a technology company requires creating a culture among all engineers and employees that encourages them to recognize and identify when they are creating innovations, which will help them protect the companys intellectual property, by documenting it and seeking patents or other forms of intellectual property protection, and will protect the company by recognizing and respecting the intellectual property rights of other parties.
