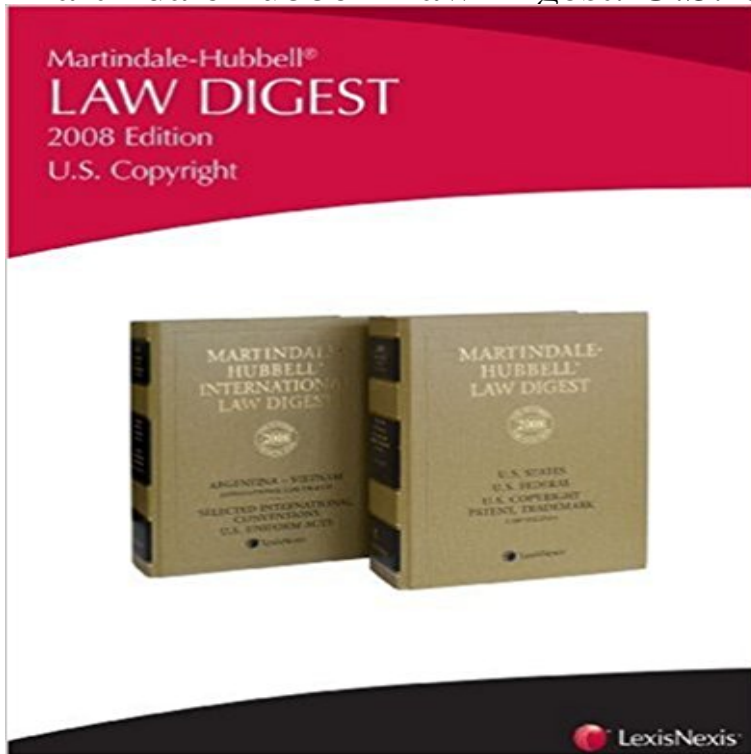


MartindaleHubbell Law Digest: U.S. Copyright

Digest content follows a hierarchical classification plan of: categories; topics; sub headings; catch lines; and cross references. The digest makes extensive use of statutory citations and presents many legal forms in facsimile.
