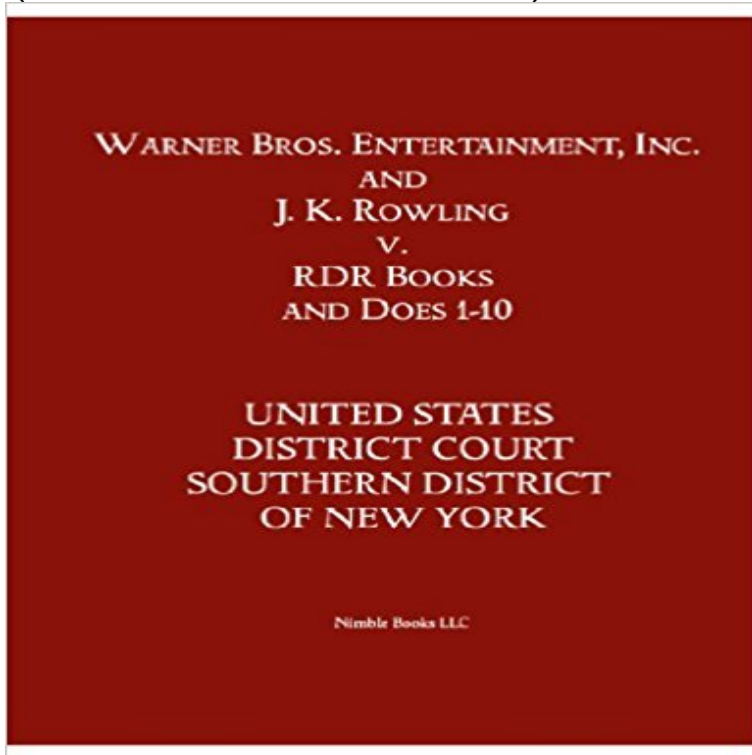


## Warner Bros. & J. K. Rowling v. RDR Books [the Harry Potter Lexicon] (Nimble Case Law Book 1)
