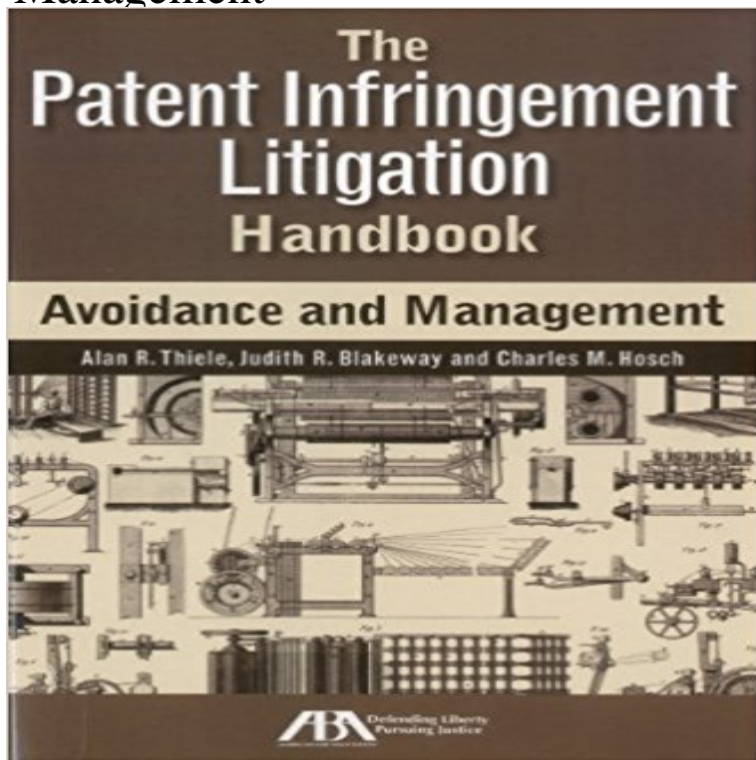


The Patent Infringement Litigation Handbook: Avoidance and Management
