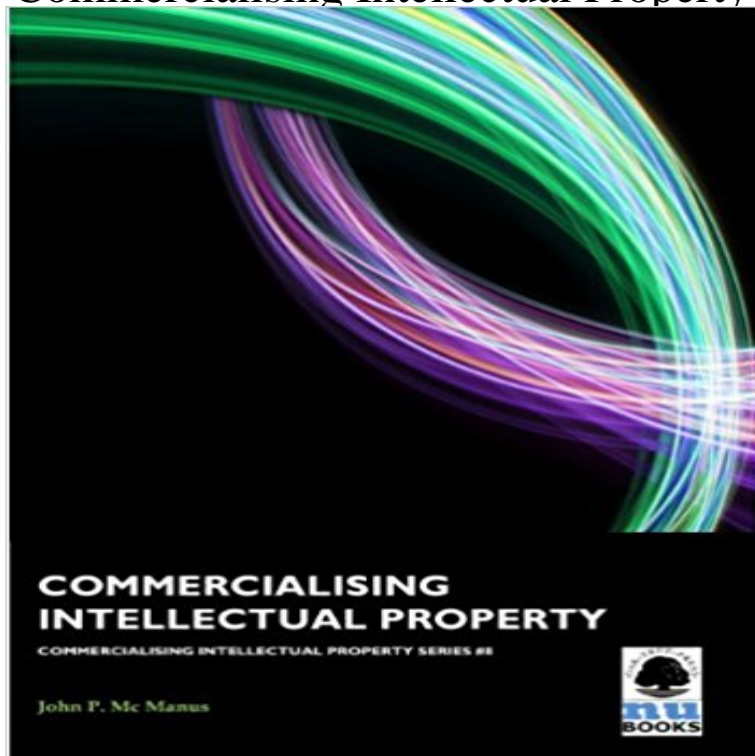


## Commercialising Intellectual Property (8)
