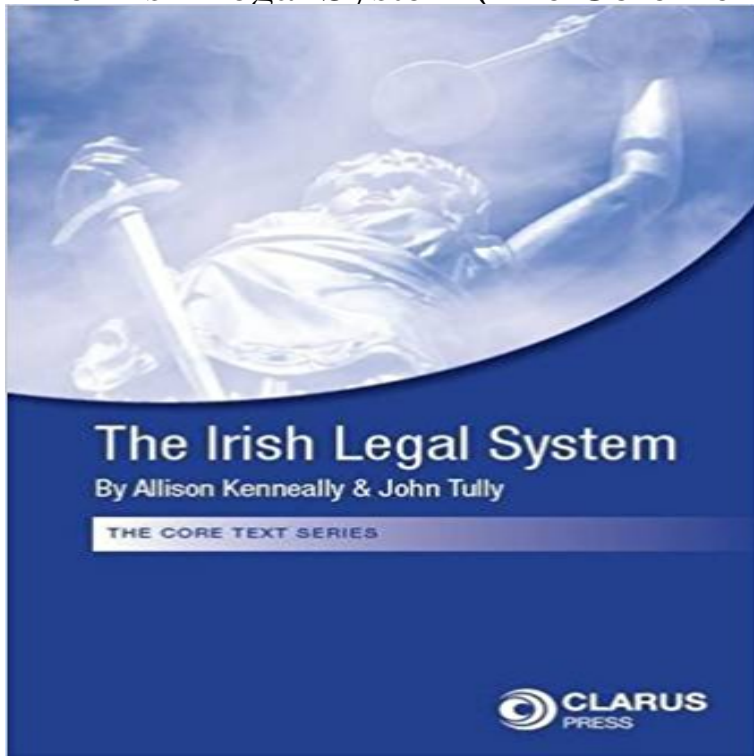


## The Irish Legal System (The Core Text Series)
