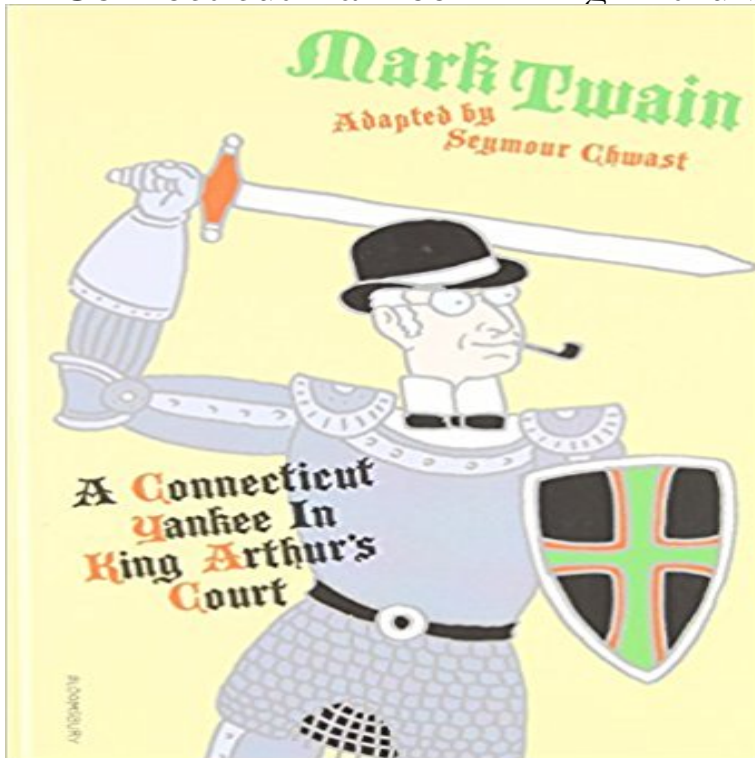


A Connecticut Yankee in King Arthurs Court
