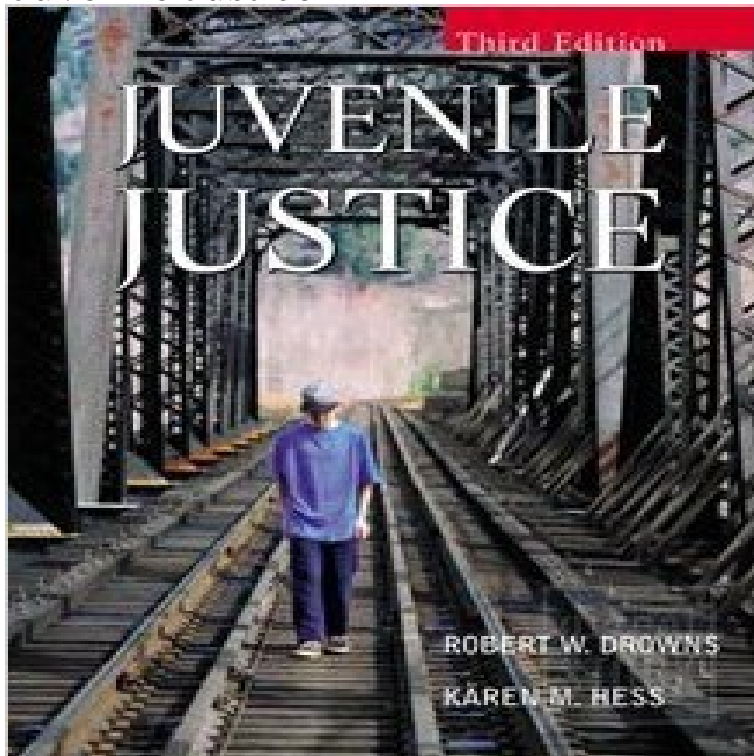


Juvenile Justice
