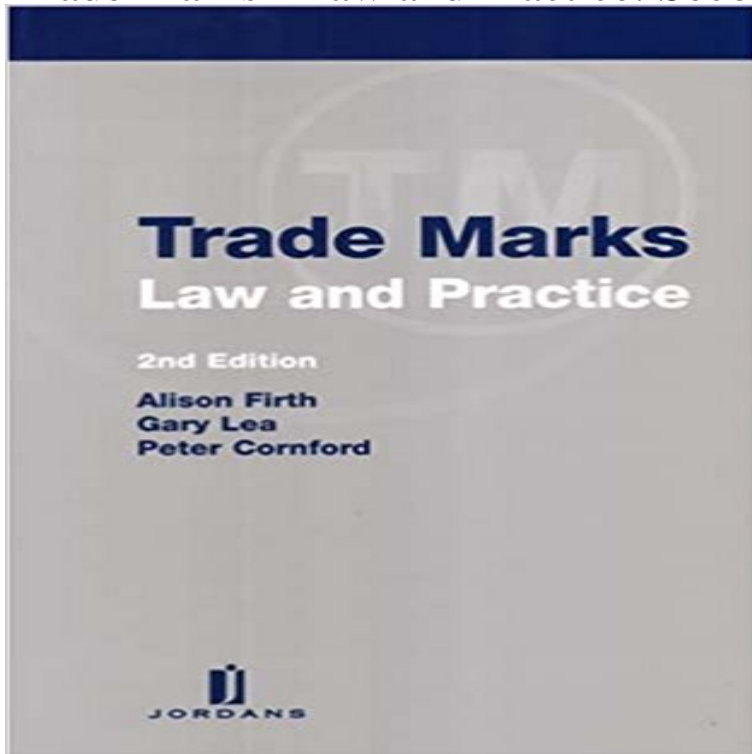


## Trade Marks - Law and Practice: Second Edition
