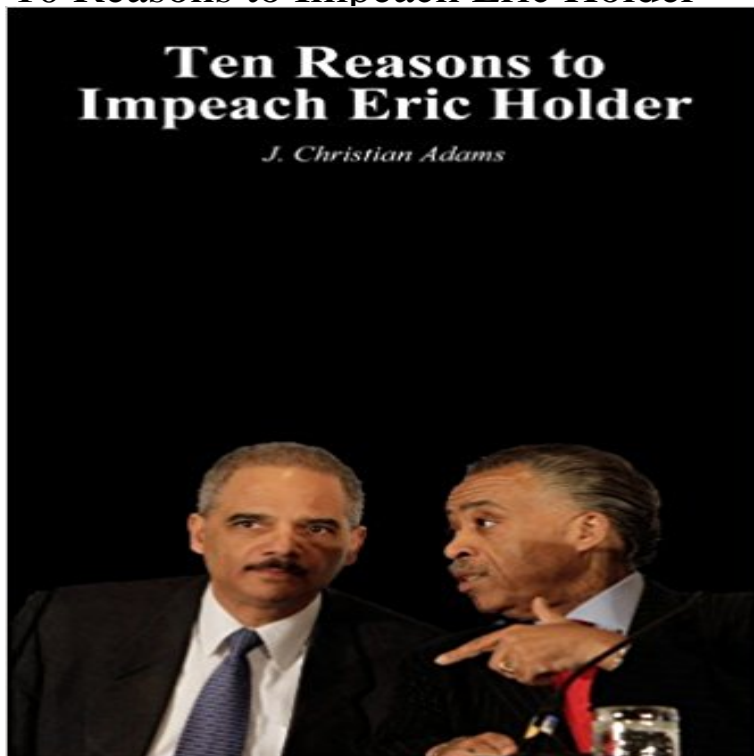


10 Reasons to Impeach Eric Holder
